# **Statement of Issue:**

This agenda item seeks the Board of County Commissioners (BOCC) approval of resolution #2012-001 and budget amendments to the FY 2011/12 budget to appropriate funds for jail maintenance and Lamb Park.

### Background:

It is requested that funds be appropriated from fund 301 (Capital Project - General Fund) to provide funding to complete various infrastructure projects at the County jail. Also it is requested that funds be appropriated from fund 344 (Capital Project - Parks Fund) to provide funding to complete the infrastructure construction and installation of equipment at Lamb Park.

### Analysis:

The \$125,000 is the cost of an installed chiller for the County jail that overlapped fiscal years. The \$250,000 is to appropriate into FY12 for various projects at the County jail. The \$45,000 is the remaining funds in FY11 that is needed to complete Lamb Park.

# **Fiscal Impact:**

By processing the attached budget amendments, funds will be appropriated to the FY 2011/2012 budget to: complete Lamb Park; to pay for a chiller for the jail and to provide funds for jail equipment and repairs/renovations.
