1. WELCOME

Mrs. Chancey commented that she had some minor injuries and had some that did not show up.

Judge Garner said she had not been made aware of any problems and commended the ones responsible for making this work.

4. **RE-ENTRY PROGRAM**

Major Robert Barkley, Gadsden County Sheriff's Department, his job was made easier with the jail reduction. He showed a slide of trustees and some of the jobs they were responsible for. He said they try to match the trustee with the job skills they possess.

ASA Allman asked if the criteria for the re-entry program were laid out in a document.

Chair Hinson recalled the ribbon-cutting ceremony at Satellite where they mentioned they would love to build a relationship with the inmates with small machine experience.

5. **QUESTIONS/COMMENTS**

Major Wood said normally this meeting is held once a year and they changed it to a bi-annual meeting. He asked that this not just be about the jail, but some of the other projects in the community. He asked that they look into juvenile crimes, DJJ, and look at the new drug "Molly".

Chair asked if anyone had topics for the next meeting and if so please forward.

Mr. Presnell said the next meeting would be in six months.
