He said that any said dog must be confined to property owner's property and can't be a nuisance to the neighborhood by barking, whining or howling in an excessive or untimely fashion.

Ms. Diaz said they are getting the cops called on them by their neighbor. She said she was trying to work with her and that they had moved the dog in the house mostly. She has made an attempt to correct the problem.

barks until it starts to howl. She said she wants it to stop. She said it effects her sleeping.

Ms. Diaz said the unidentified man (Children's father) bought a shot caller for the dog. He said the collar has a sensor on it. It makes the dog stop barking.
