Violation: Mr. and Mrs. Kyllonen have committed repeat violations of the Code of Ordinances by allowing junk and trash to accumulate on the property. On January 5, 2017, the owners were ordered to clean up the property and comply with the Code of Ordinances. To date, the owners have not complied.

Mr. Kyllonen said he was noticed at the door, but he did not receive one by mail. He admitted that the property needs to be cleaned up. He said most vehicles are registered and insured and provided the information for the courts for the ones that were. He said the ones up front are in compliance. He said the stickers are not on vehicles. He said he was not contesting it needs to be cleaned up. He asked if he could be given to the end of the month to get it cleaned up.

Judge Parsons said this had been coming up for the last 4 years, that he had violated the Code. He said that he was intentionally putting stuff on the property that cannot go. He then entered an order with cost and fines and to clean up within 15 days.

Mr. Williams said he thought if he moved off county right away and got in compliance it should be good.
