5. PUBLIC HEARING: (Legislative)-Adoption of Ordinance #2018-004 for the Perkins Small Scale Comprehensive Plan Future Land Use Map Amendments

Mrs. Jackson introduced the above item and said this was a Small Scale Comprehensive Plan Future Land Use Map Amendment that would be presented by Jill Jeglie, Senior Planner.

Jill Jeglie discussed this item and said it was a 6.7 acre parcel located on Scotland Road, Havana and the applicant proposed the amendment from Agricultural to Commercial and is an electrical contractor and wished to move his company from Leon County to this property.

Brad Johnson, Assistant County Administrator, appeared and said boundaries have been extended to include areas in Walton County with an expiration date of July 8, 2020.

7. Write-Off EMS Accounts-Bad Debt

Andre Walker, Interim EMS Director, appeared before the Board and discussed this item. He said the accounts would be submitted to outside collection agencies to attempt to collect the outstanding debts.

8. Approval of the County Email Policy Number 18-02

Mrs. Jackson introduced the above item.

She said they basically scrapped the old policy that dealt with email and internet usage in one policy and this would deal directly with the email policy.

Commissioner Viegbesie said the way he handled it, if an email was sent to his personal email, he would request that the person send to his County email. Mr. Weiss said if an email was sent to his personal email that pertained to County business; it still became a matter of public record.

9. Approval of the County Internet Usage Policy Number 18-01

Mrs. Jackson introduced the above item. She said this original policy was adopted in 2005 and technology had changed so much since then. She said they had broken out the two and they now had a four page Internet policy that addressed strictly internet usage. She said this did allow an opportunity for Staff to use the internet even if it was personal but could not conflict with their day-to-day and should not total more than 10 minutes of their time the entire day.

Commissioner Viegbesie said he hoped they were prepared for a lengthy conversation regarding this item.

10. FDOT Highway Beautification Program at I-10 Interchanges

Mrs. Jackson introduced the above item.

Commissioner Viegbesie said his dream was when people drove past Gadsden County on I-10, he wanted the four interchanges to catch their eyes and attract visitors and businesses to come.

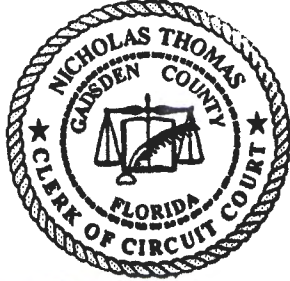
